

GP healthcare	
Medical healthcare by GP, including laboratory research	100%
Obstetric healthcare and maternity healthcare	
Obstetric healthcare, including use of delivery room if delivery takes place in a hospital	100%
Maternity healthcare by maternity nurse	Reimbursement for a minimum of 24 hrs and up to 80 hrs, divided over up to 10 days from the day of delivery, up to an amount of €1,500.00
Medical specialist healthcare	
Medical care by a medical specialist, including laboratory research	Fully, after approval from insurer. There is no entitlement for: treatments for snoring with uvuloplasty; treatments aimed at reversing a sterilisation; treatment aimed at circumcision
Rehabilitation	
Research, advice and treatment of combined medical-specialist, paramedical, behavioural of a scientific and rehabilitation of a technical nature by a multidisciplinary team of experts linked to a rehabilitation institution	100%
Genetic testing	
Investigation into and of genetic hereditary diseases, after referral by a GP or medical specialist. If required for the advice to the insured person, investigation will also comprise of: investigations of other persons than the insured person	100%
In vitro fertilisation (IVF) and other fertility enhancing treatments	
In-vitro fertilisation (IVF) / ICSI by a gynaecologist in a licensed institution	First 3 attempts per completed pregnancy, including the associated medicines
Other fertility enhancing treatments (surgery and artificial insemination)	100%. There is no entitlement to medicines that are intended to promote fertility
Audiological healthcare	
Medical care by an audiologic centre or comparable centre associated with: investigation into auditory function; advice on hearing equipment to be purchased; information on the use of the equipment; psychosocial care if necessary due to auditory dysfunction problems; assistance in diagnosing speech and language disorders for children up to 7 years of age	100%

Dental care up to 18 years of age	100% for general dental care. No reimbursement is
bental care up to 10 years of age	granted for regular orthodontics, dental crowns, tooth bridges and implants
Orthodontics	 up to 18 years: up to €2,270.00; from 18 years: single payout of €1,135.00
Dental care and orthodontic care in exceptional cases, with a dentist or orthodontist attached to a Centrum voor Bijzondere Tandheelkunde, a dentist or orthodontist with proven expertise and experience or an oral surgeon	Fully, after approval by insurer. A small personal excess payment may apply
Specialist dental surgery assistance (dental surgery), including the corresponding X-ray investigation	Fully, except periodontal surgery and fitting of dental implants
Dentures for insured people of 18 years and older	
Removable full dentures for upper and / or lower jaw	Up to €750.00 per prosthesis. A personal excess of 25% of the costs of a prosthetic provision applies

Delivery of medicines registered in the country of residence prescribed by a doctor	Fully. Prior approval from the insurer is required for medicines that exceed €500.00 per delivery

Stays	
Medically required stay in a hospital, rehabilitation centre or care hotel	Fully, up to a maximum of 365 days, after prior approval by insurer (if possible) and in cooperation with emergency services
Ambulance transport	
Ambulance transport (medically required)	Fully
(medically necessary) by car, taxi or public transport (medically required) by car, taxi or public transport	Fully, after approval by insurer. A personal excess of € 100.00 per calendar year applies
Other reimbursements	
Alternative medicine, therapies and medicines	Up to €1,000.00 per insured person per calendar year
Contraception (including Nuva ring; Mirena (IUD); Implanon and contraceptive pill)	100%. No reimbursement will be granted for the purchase of condoms
Sterilisation in a hospital	100%. No reimbursement will be granted for costs of reversing the sterilisation
Abroad/Rest of the World	
Repatriation to the country of residence	Fully, after approval by emergency centre
Transport of mortal remains to home country	Fully, after approval by emergency centre
Vaccinations for holiday travel abroad	100% for consults, medicines and vaccinations to prevent malaria, DTP, yellow fever, typhoid, cholera, hepatitis A and B

Psychological care	
Primary psychological care	Up to €455.00 per calendar year
Skin treatments	
All skin treatments at the direction of the GP	Up to €500.00 per insured person per calendar year, after approval by insurer
Prevention	
Preventative courses focused on losing weight, quitting smoking and heart problems	€ 150.00 per 2 calendar years
Preventative medical examinations for early detection of: cervical cancer (pap smear), breast cancer, electrocardiograms, diseases of the heart and blood vessels (up to once every 24 months), prostate cancer	Fully
Influenza vaccination	100% once per calendar year
Stutter therapy	
The costs of stutter therapy	€1,000.00 once during the running time of the insurance
Foot treatment / podiatry	
Podiatry (consultations and costs of measuring, manufacturing and supplying of podiatric soles and orthoses)	€70.00 per insured person per calendar year

Aevitae Dental Packages	
Dental costs according to the UPT-standard	Reimbursement including technical costs is granted annually for the maximum amount per insured person per year listed on your healthcare policy. Excluded from reimbursement are: costs related to orthodontics; external bleaching, regardless of the number of elements per jaw; materials for home bleaching, the cost of implants, with the exception of upper and lower dentures, lower dentures and upper denture; the cost of a dental technician and / or dental laboratory, missed appointments
